2. CONFIRMATION OF PREVIOUS MEETING MINUTES

3. CLUB REPORTS

- Chair Report this was presented via email. There were several changes in volunteer roles, including Tania Burdett as the Tuesday Night Co-ordinator, and Mark Skelsey as the Officials co-ordinator. There have been a lot of changes and adapting due to the impact of Covid-19. As a Club, we are continually looking for engagement by the parents, wherever they can volunteer. Regarding the possible change of brand, it was confirmed that some swimmers were keen to be known as Raptors at meets, dropping the reference to Raumati. It is still an evolving idea and no decision has been made. Henrietta confirmed that the Life Members have been approached by swimmers and their feedback has been presented to the Board for consideration. No decision can be made without the members' approval.
- Treasurer's report The report and Accounts for 2019/2020 were presented via email. There was a loss of \$1k, and \$3k of grants have been rolled over to the 2020/21 financial year. Grants dried up due to Covid-19 and 2 that had been awarded were withdrawn. 40% of the income received was squad fees which were then paid to CWS. 20% of income was from the Tuesday night/Teen fitness and is mainly profit. Chris thanked all the volunteers involved in the Tuesday night groups, as well as Lizzie Plummer for her determination in applying for grants. The club is in a reasonable financial position, especially having gone



through covid-19 this year. But we still need to look at ways of increasing the pre-squad groups. Asked about the introduction of the Club levy last year, Chris confirmed that in the 2019/20 financial report, it stated that the fees were to be used for operating costs. The increase that had been proposed for 2020/21 would have been used towards a junior/additional coach. Due to Covid-19, this increase was not introduced. Asked about the level of the reserves, this only represents 3 years of grant income. Other clubs have similar reserves.

- Coach Report A competitive Coach report was presented via email. The Head Coach was
 not at the AGM to answer questions. Concern was raised about the Arena sponsorship, and
 who the agreement is with. It was confirmed that the agreement is between the swimmers
 and Arena, for NZSC Champs. Any clothing within this agreement, needs to be one-off and
 classed as memorabilia, and should have the Meet information on it. When asked whether
 the Board are happy for a private enterprise to sponsor memorabilia, several members felt
 it was a good initiative.
- Tuesday Club Night this was presented via email.
